1. GinoD welcomed all attendees and outlined the Agenda of the "short" meeting:
 - VMAP-SC community formalisation
 - VMAP-SC meeting and event plans for 2020
 - Questions & Answers
2. GinoD then presented an overview of the VMAP Standards Community (VMAP-SC) size, 90 entities in database, and external use cases discussions, 15 interest parties. The process for the VMAP-SC legal and organizational creation was briefly presented; see [1] pages 2-5. Points for discussion:
 - There will be no costs charged for usage of VMAP, nor for re-distribution within processes or software. However, there will be a "membership fee" for those entities who wish to develop VMAP or to influence the continuity of VMAP and to maintain the necessary management of the Community and its projects and work.

3. GinoD presented the plans for 2020 that include:
 - International Conference on CAE Interoperability on 13-14 May 2020, see [1] page 6.
The conference will start with a plenary session after lunch on 13 May and end at lunch or early afternoon on 14 May.
About 30 abstracts have been received.
Gino D encouraged attendees to promote the conference by emailing the link to persons who may be interested and please include link on company website if possible.
 - VMAP-SC meetings, see [1] page 7, possibly
 - o F2F in May 2020 at the conference,
 - o Web meeting possibly in April 2020 (if not at the conference) or September 2020.
 - the Final Project Presentation on 22 October 2020 at Philips Drachten (The Netherlands) that will be open to all and include a factory tour at Philips Consumer Lifestyle.
4. Further discussion was related to Transvalor's implementation of VMAP. Transvalor are committed to this but it requires some agreement on using the IO software library.
Action: KlausW and GinoD will look at the Licence Agreement draft and modify to suit (since there is no official VMAP-SC yet).
Action: LaurenceG will look at their NDAs to see if something is adequate.
5. GinoD thanked everybody for their participation and closed the meeting.

 - 35 confirmed interest, 50% external to project
- External use cases
 - Manufacturing Technology Centre (UK)
 - Autodesk Moldflow
 - Forge (Transvalor)
 - 12 other interested (downloaded documentation)

VMAP Community Members:



VMAP has already been directly integrated into CAE tools like MSC-Marc, MSC-Nastran, CadMould, PAM-RTM, PAM-Crash, Open-FOAM, COMPRO and RAVEN as well as independent/neutral translation tools like envyo that supports the LS-DYNA suite, Digimat, FiberMap, MpCCI and the ANSA pre-processor.

The VMAP project objectives are endorsed by Audi, Bosch, EDAG, Rikutec and Philips.






